Articles must be contributed solely to the Journal of the ASEAN Orthopaedic Association and when published become the property of the ASEAN Orthopaedic Association. ### Preparation of manuscript

Type manuscript, double spaced, on regular typewriter paper of 8 1/2" x 11" with at least one inch margins on both sides and bottom. Begin each of the following sections on separate pages: title page, abstract of not more than 150 words, text, acknowledgements, references, individual tables, and legends.

On the first page or the title page give the title of article, name(s) of author(s) including first name, degrees, name of department and institution in which the work was done. Number pages consecutively, beginning with the title page. Type the page number in the upper right hand corner of each page. An original and two additional copies of all materials including figures and tables must be submitted for editorial review. Metric measurements should be used throughout the text and illustrative materials.

### Illustrations

Glossy black and white photographs of illustration are requested. Original drawing should be professionally drawn in black Indian ink. Typewritten or freehand lettering is not acceptable. Color illustrations will be published at the

authors' expense. Be sure to indicate "top" in pencil on the back of each illustration. Supply a caption for each illustration and type double spaced on a sheet of paper separate from the illustrations. Do not mount the illustrations in the manuscripts but submit them to accompany the manuscripts.

### Tables

Type each table and its title on a separate sheet of paper. Use Arabic numerals to number tables and should be numbered consecutively as mentioned in the text. Each table must be able to stand alone or all necessary information must be contained in caption and the table itself so that it can be understood independently of the text. Do not repeat information that is given in the text, and do not make a table for data that can be given in the text in one or two sentences.

### References

References must be listed on a separate sheet in numeric order as referred to in the article, not alphabetically. Only references mentioned in the text should be listed and should be selective. Number references consecutively in the order in which they are first mentioned in the text. Used the form of references and the titles of journals abbreviated according to the style used in Index Medicus.

Information from manuscripts submitted but not yet accepted should be cited in the text as "unpublished observation" (in parentheses). References must be typed doubled-space.
